

# Privacy Policy

## smartPRO SAFETY system

GoodPRO, s.r.o. built the smartPRO SAFETY system app as a Free app. This SERVICE is provided by GoodPRO, s.r.o. at no cost and is intended for use as is.

This page is used to inform visitors regarding our policies with the collection, use, and disclosure of Personal Information if anyone decided to use our Service.

If you choose to use our Service, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

The terms used in this Privacy Policy have the same meanings as in our Terms and Conditions, which is accessible at smartPRO SAFETY system unless otherwise defined in this Privacy Policy.

### Information Collection and Use

For a better experience, while using our Service, we may require you to provide us with certain personally identifiable information. The information that we request will be retained by us and used as described in this privacy policy.

### Log Data

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol (“IP”) address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.

### Cookies

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.

This Service does not use these “cookies” explicitly. However, the app may use third party code and libraries that use “cookies” to collect information and improve their services. You have the option to either accept or refuse these cookies and know when a cookie is being sent to your device. If you choose to refuse our cookies, you may not be able to use some portions of this Service.

### Security

We value your trust in providing us your Personal Information, thus we are striving to use commercially acceptable means of protecting it. But remember that no method of transmission over the internet, or method of electronic storage is 100% secure and reliable, and we cannot guarantee its absolute security. SMS are intended only for the personal security of the user.

### **Children's Privacy**

# Terms & Conditions

## smartPRO SAFETY system

### 1. Definitions and binding effect:

- "Terms of Use" - Terms of use for smartPRO SAFETY system.
- "Operator" - GoodPRO, s.r.o., Plzeňská 297, Zbůch, Czech Republic, smartpro@goodpro.cz
- "Application" - application means smartPRO SAFETY system mobile application.
- "User" - is a natural or legal person who downloads the app from the Google Play Store or another source, or opens the web app in any browser.
- The terms are binding for users of both mobile applications from the moment the user installs / opens the application on their mobile phone.

### 2. Terms of Use:

- The application is intended for users over 13 years of age.
- The User acknowledges that from the moment of downloading the application, the User and the Operator conclude a contract for the provision of services. The content of the mutual rights and obligations of the user and the operator is regulated mainly by these terms of use, but also by the valid legal regulations of the Czech Republic, especially by the standards of copyright. The Operator shall not be liable for damages to himself or to third parties, caused by the user using the application incorrectly.

### 3. License

- The User is authorized to use the Application only in accordance with these Terms of Use. The user is not authorized to modify or modify the application.
- By using both mobile applications, the user acknowledges the fact that all content of the application is the sole property of the operator.
- The user is authorized to use the content of the application only for his / her personal use.

### 4. Use of applications:

- smartPRO SAFETY system can be used by purchasing GoodPRO protective clothing equipped with special RFID chip.
- The user uses the application via their mobile phone.
- The Operator is entitled to limit or completely prevent the use of the application without prior notice. The Operator may also do so in relation to a particular user if he reasonably believes that the user is using the application in violation of these terms of use. The user is not entitled to any compensation or compensation in connection with the above-mentioned action of the operator.
- The User acknowledges that the Application may not be available continuously, especially with regard to the necessary maintenance of the hardware and software equipment of the Operator, respectively necessary maintenance of the hardware and software equipment of the third party. Potential unavailability of the Application is not considered a fault on the part of the operator and the user can not rise any claims against the operator.
- SMS are intended only for the personal security of the user.

## 5. Application security

- The Operator provides Application Users with the highest possible protection against loss or misuse of data created within the application.
- The operator also carries out regular checks against any unauthorized penetration.

## 7. Conditions

By downloading or using the app, these terms will automatically apply to you – you should make sure therefore that you read them carefully before using the app. You're not allowed to copy, or modify the app, any part of the app, or our trademarks in any way. You're not allowed to attempt to extract the source code of the app, and you also shouldn't try to translate the app into other languages, or make derivative versions. The app itself, and all the trade marks, copyright, database rights and other intellectual property rights related to it, still belong to GoodPRO, s.r.o..

The smartPRO SAFETY system app stores and processes personal data that you have provided to us, in order to provide our Service. It's your responsibility to keep your phone and access to the app secure. We therefore recommend that you do not jailbreak or root your phone, which is the process of removing software restrictions and limitations imposed by the official operating system of your device. It could make your phone vulnerable to malware/viruses/malicious programs, compromise your phone's security features and it could mean that the smartPRO SAFETY system app won't work properly or at all.

You should be aware that there are certain things that GoodPRO, s.r.o. will not take responsibility for. Certain functions of the app will require the app to have an active internet connection. The connection can be Wi-Fi, or provided by your mobile network provider, but GoodPRO, s.r.o. cannot take responsibility for the app not working at full functionality if you don't have access to Wi-Fi, and you don't have any of your data allowance left.

If you're using the app outside of an area with Wi-Fi, you should remember that your terms of the agreement with your mobile network provider will still apply. As a result, you may be charged by your mobile provider for the cost of data for the duration of the connection while accessing the app, or other third party charges.
